They are looking to apply for a FEMA grant. They are purchasing three new garage doors. They are renewing the mutual aide agreement. There are seven applicants for full time positions.

Mr. Parsons reported on the Batavia-Union Cemetery. Wayne Smith would like to stay on as Sexton. There will be an executive session at the next meeting to work something out. We are buying back a few cemetery lots. There was a 12-lot purchase by one family who will only use two. We will buy back ten of those.
